#### **Call to Order**

Jenna Hiester called the Zoom meeting to order at 6:02 p.m.

### **Approval of Minutes**

Moved by Mr. Lineaweaver and seconded by Mr. Adams to approve the minutes of November 16, 2020. Motion carried.

### **Community Garden Update**

Mr. Kaag reported that the garden is now closed for the season. The items donated by Lowe's should be arriving next week, which includes a shed, benches, wood to repair garden beds, garden lighting and paint for a mural.
