## Discussion of Budget:

- Presented budget and updated fee schedule (from September 2020 meeting). Borough
  Council feels that prices need to be raised, but putting the higher prices on non-residents,
  not on residents
  - o Playground fees increased for non-residents, but not residents
  - o Pool rates increased for non-residents, but not residents
  - o Rates will go to price proposed by Recreation Commission, not higher
  - Rental rates (Bicentennial House, Pavilion) increased for non-residents, residents stay the same (slight increase at Bicentennial House)
- Need to cut expenses by another 5%

- Can wait one more year before major pool renovation needed. Will request Council to set aside money over two years to pay for it in 2022.
  - Capital projects in recreation buildings/areas need to be done in order to have facilities and events.
- Discussion of ways to cut expenses, including cutting events, looking for donations/advertising, etc.

Rental of Bicentennial House: ask Council to rent to bring in revenue.

- Need COVID-19 liability waiver
- Council decision
- Need to clean & sanitize after an event
- Limited availability (only one rental per weekend)

Motion to ask for Borough Council approval to re-open rental of the Bicentennial House to raise funds for the Recreation Commission made by Kristina Singleton. Seconded by Nikki Frymoyer. Motion carried unanimously (5-0).

Motion to adjourn made by Nikki Frymoyer. Second made by Kristina Singleton. Motion passed unanimously (5-0).
