Discussion

 Not much happening in recreation in West Reading and other municipalities due to COVID-19 procedures, CDC rules and guidelines, and the PA Governor's guidelines.

Events

- Something to bring the borough "together" and cultivate a sense of community
 - Scarecrow decorating contest in September (gift cards as prizes); try to get local businesses involved; kick off Fall Recreation
 - Halloween: goody-bags at borough instead of trick or treat, potentially at pavilion or Bicentennial House, or deliver to borough homes
 - Have a plan "A" and plan "B" so that more can be done if possible, but not disappointing if the event is minimal
 - Can advertise at the beginning of October
 - Pre-registration for kids
 - Only for kids in West Reading
 - Can ask for donations
 - o Halloween decorating contest (similar to holiday lights with pool passes as prizes)
 - Community-wide holiday lights—everyone light them up at same time; potentially have goody bag drop offs with Santa and Mrs. Claus
 - o Decorated tree at Borough Hall
 - Holiday lights decorating contest December 20
- Previous event discussions:
 - o Will not be able to move forward with movie-in-the-park
 - Food trucks are already booked, will likely not be able to move forward with that either
 - Scavenger Hunt: 2 people participated in June

 Re-doing scavenger hunt starting August 5 for one week (deadline August 14 to email or dropped off at Borough Hall) with fewer questions with prizes for the winner

Borough Rentals

- Bicentennial House is not being rented out due to difficulty in enforcing COVID-19 restrictions
- Pavilion is being rented because it is an outdoor building
