

RESOLUTION NO. 2022-3

A RESOLUTION OF THE BOROUGH OF WEST READING, BERKS COUNTY, PENNSYLVANIA REQUESTING A STATEWIDE LOCAL SHARE ASSESSMENT GRANT FROM THE COMMONWEALTH FINANCING AUTHORITY; TO AUTHORIZE THE MAYOR AND BOROUGH MANAGER TO SUBMIT AN APPLICATION REQUESTING A STATEWIDE LOCAL SHARE ASSESSMENT GRANT; TO EXECUTE ALL DOCUMENTS AND AGREEMENTS RELATED TO THE GRANT; AND TAKE ACTION TO ASSIST IN OBTAINING THE GRANT

WHEREAS, the Borough of West Reading ("Borough") is a municipal corporation organized, operating, and governed by the Borough Code, 8 Pa.C.S. § 101, et seq., as amended and supplemented; and

WHEREAS, the Borough desires to submit an application for a Statewide Local Share Assessment Grant in the amount of \$275,000.00 from the Commonwealth Financing Authority to be used to upgrade the existing security camera system, to purchase additional security cameras, and to purchase an additional server for the security camera system backup ("Security Camera System Project"); and

WHEREAS, the Borough desires to designate Samantha Kaag, Mayor and Dean Murray, Borough Manager as the Borough officials authorized to execute all documents and agreements between the Borough of West Reading and the Commonwealth Financing Authority to facilitate and assist in obtaining the requested grant;

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of West Reading, Berks County, Pennsylvania, as follows:

1. The Borough authorizes Samantha Kaag, Mayor and Dean Murray, Borough Manager, to submit an application for a Statewide Local Share Assessment grant in the amount of \$275,000.00 from the Commonwealth Financing Authority to be used for the Security Camera System Project.
2. The Borough further authorizes Samantha Kaag, Mayor and Dean Murray, Borough Manager, to execute all documents and agreements between the Borough of West Reading and the Commonwealth Financing Authority to facilitate and assist in obtaining the requested grant;
3. This Resolution shall become effective and be in force immediately.


