- 1. **SWEARING IN OF COUNCIL MEMBERS:** It was noted that all members of Council had previously been duly sworn in and copies of their Oaths of Office have been received by Borough Staff.
- 2. **CALL TO ORDER:** Mayor Samantha Kaag called the meeting to order at 6:05 p.m., which was followed by the Pledge of Allegiance and Roll Call.

**Moved** by Mr. Shaver and seconded by Mr. Lincoln to appoint Mr. Wert as Council Vice-President. **Motion carried 7-0.**

Council also discussed the following as part of the appointments to Committees/Boards etc.:

- A Request for Proposals will be advertised for the Zoning Hearing Board Solicitor position. The current solicitor will be advised and invited to submit a proposal.
- With Zachary Shaver having become a member of Council, there would be four Council members on the Planning Commission which is not permissible under the Sunshine Law. Mr. Shaver offered to step down from the Commission. The vacancy will need to be advertised.

- Mr. Wert asked that Jack Gombach be added to the Economic Development Committee.
- Council appointed Ms. Drobnick as chair of the Recreation Commission. There was also discussion concerning the level of negativity and discord that has been prevalent at Recreation meetings. As well, there were members frequently missing meetings and a lack of volunteerism among members. Therefore, some changes in membership were requested. Jennifer Witman and Alex Humphrey have asked not to be reappointed; Colleen English, Kristen Hawley and Nathalie Kulesa have requested to be reappointed, and three letters of interest have been received. Council asked that the appointments to the Recreation Commission be tabled until the January 18<sup>th</sup> meeting.

- Mr. Wert spoke about the Finance Committee that has not met for a couple of years and asked that the Committee be revitalized. After some brief discussion, Ms. Bressler and Mr. Lineaweaver volunteered to lead the Committee. The vacant seats will be advertised.
- Council asked that the Pension Fund Committee meet with the pensions' financial advisors at least once per year. Mayor Kaag also requested to be appointed to the Committee. Mr. Murray will meet with the Treasurer and Ms. Bressler to discuss moving forward.
- Mr. Murray will meet with the Mayor to discuss the Water System Emergency protocols.

Motion by Mr. Lincoln and seconded by Ms. Bressler to approve all appointments as discussed with the exception of the Recreation Commission. **Motion carried 7-0.** 

**Resolution 2022-1 Reaffirm Zoning Hearing Board** – Due to Ms. Drobnick being elected to Council she can no longer be a member of the Zoning Hearing Board therefore the resolution reaffirms the remaining Zoning Hearing Board members.

Motion to approve Resolution 2020-1 to reaffirm the Zoning Hearing Board Members. **Moved** by Mr. Wert and seconded by Mrs. Kaag. **Motion carried 7-0.** 

- 6. **EXECUTIVE SESSION:** It was announced that Council had met in Executive Session immediately prior to this meeting to discuss personnel and that no action had been taken.
- 7. **PUBLIC COMMENT:** There was no public comment.
- 8. **ADJOURNMENT: Moved** by Mr. Lincoln and seconded by Mr. Kaag to adjourn the meeting at 7:16 p.m. **Motion carried 7-0.**
