Mr. Imbesi stated the Finance Committee agenda would be revised to work towards earning more on investments and ease budgeting burdens. The committee has two vacant resident positions, one of which a resident has expressed an interest and will submit a letter. The second vacant position would need to be advertised. Also, the meeting date has been revised to the Thursday prior to Council meeting at 6:00 p.m.

- b. **Real Estate Tax Collector** Mr. Malloy noted that Jason Ulrich (who was not in attendance) had been elected to the position of Tax Collector and will need to be sworn in.
- c. **Fee Schedule** Council reviewed the highlighted fee schedule changes.
 - Mr. Wert inquired as to Street Opening Permit revisions. Mr. Lincoln noted the revisions allow additional fees to be collected based on the length of the opening.
 - Mr. Mullen inquired as the flat Playground fee per child. Mrs. Moyer noted a discount period and payment plan option, however the fee needed to be increased to cover expenses.
 - Mr. Gardecki inquired as to the addition of a Public Right-of-Way License. Mrs. Madeira noted an annual license fee pertaining to the addition of wireless communication facilities.

Motion to approve Resolution 2018-1 Fee Schedule. **Moved** by Mr. Gardecki and seconded by Mr. Amato. **Motion carried 7-0.**

- d. **Town Gown Meeting** Mrs. Hoffman noted this meeting is between the school board, Wyomissing and West Reading Borough to discuss common issues. The committee meets on a quarterly basis and is scheduled to meet next Wednesday, January 10, 2018 at 5:30 p.m. at Wyomissing Borough Council Chambers, which conflicts with the Traffic and Infrastructure meeting. Mayor Kearney and Mr. Amato agreed to attend this meeting.
- e. **Other** Mr. Wert noted draft ordinances the Planning Commission has had difficulty in devoting time to discuss details such as Board of Appeals, Disruptive Conduct, Quality of Life, and Rental Occupancy. Mr. Wert suggested the second Council meeting of the month be an option to discuss details of draft ordinances. Mr. Imbesi requested Council bring suggestions to the next Council meeting.

Mrs. Hoffman noted Western Berks Water Authorities request for two Council members to participate in a study coordinated with Shillington and Wyomissing Borough to accommodate regulations promulgated by DRBC and DEP. Mr. Lincoln and Mr. Gardecki agreed to attend these meetings.

- 5. **EXECUTIVE SESSION:** Council recessed to Executive Session to discuss personnel at 8:05 p.m. When the regular session reconvened at 8:21 p.m. no action was taken.
- 6. **PUBLIC COMMENT:**

Mr. Rogers inquired as to the hospital's responsibility to repave roadways.
