1. **CALL TO ORDER:** Mayor Andrew Kearney called the meeting to order at 7:00 p.m., which was followed by the Pledge of Allegiance and Roll Call.

2. PUBLIC COMMENT:

Barbara Griesemer referred to a tract of land located behind the homes of 21 and 23 S. Seventh Avenue and 661 Franklin Street that are adjacent to the Municipal Parking Lot where her son, Jeffrey Reiff would like to use the land as a parking area for his auto repair business located at 633 Cherry Street. Ms. Griesemer has obtained copies of the three deeds and plots from the County Courthouse for the properties in question and asked if she was in the right meeting to discuss. It was recommended that Ms. Griesemer arrange a meeting with the Borough Manager to review these documents and determine a course of action.

Resolution 2020-2 Spring Township Fire Inspection Intergovernmental Agreement Amendment – Mr. Imbesi reported that the State recently amended legislation to allow intergovernmental agreements to be amended by resolution and noted the amendment would extend the term one year, retain the current rates for the calendar year 2020 with a 4% increase to the rates for the 2021 calendar year.

6. ANIMAL CONTROL SERVICES:

Mr. Imbesi referred to Safety Net Sanctuary's Animal Control Services Agreement that requests a \$1,000 contribution for services during the calendar year of 2020. It was noted that Safety Net Sanctuary would not transport animals, handle feral cats or aggressive animals, nor investigate animal cruelty cases. Council members agreed that this contract is not ideal, however it would provide the minimum state requirements. It was recommended to continue searching for a more suitable contract.

Motion to enter into an animal control services agreement with Safety Net Sanctuary. **Moved** by Mr. Wert and seconded by Mr. Kaag. **Motion carried 6-0.**

7. **EXECUTIVE SESSION:** Council recessed to Executive Session to discuss two personnel issues, attorney client privilege and possible litigation items at 7:45 p.m. When Council reconvened at 8:26 p.m. the following action was taken:

8. PUBLIC COMMENT:

Mr. Rogers requested clarification on the hiring of an additional parking enforcement officer. Chief Powell stated that the part-time parking enforcement officer would step down to allow the hiring of a second full-time parking officer to work a night shift.

Mr. Rogers requested a progress report on the Lofts at Narrow. Mr. Imbesi stated this is an ongoing legal matter that cannot be discussed in public.

9. **ADJOURNMENT: Moved** by Mrs. Kaag and seconded by Mr. Wert to adjourn the meeting at 8:29 p.m. **Motion carried 6-0.**
