In consideration of the Borough permitting the event, I and on behalf of my heirs, executors, administrators, successors and assigns, to the fullest extent permitted by law, hereby: (1) expressly waive and release any and all claims, losses, actions, suits, proceedings, costs, expenses, fees, damages and liabilities of any kind or nature whatsoever against the Borough and its supervisors, officers, employees, representatives, agents, volunteers, attorneys, insurers, and their respective heirs, representatives, successors and assigns (collectively, "Releasees") that may arise from or is in any way related to my attendance to the event, including but not limited to injuries, illnesses, disabilities and deaths caused by COVID-19; and (2) agree to defend, indemnify, release, and hold harmless Releasees from and against any and all claims, losses, actions, suits, proceedings, costs, expenses, fees, damages and liabilities of any kind or nature whatsoever, including but not limited to reasonable attorney fees and costs, and any and all other costs and expenses incurred by the Borough in enforcing any right to indemnification pursuant to this Agreement, and the cost of pursuing any and all insurance providers, incurred by and/or awarded against the Releasees in a final non-appealable judgment, that may arise from or is in any way related to my attendance to the event, including but not limited to injuries, illnesses, disabilities and deaths caused by COVID-19. If any term or provision of this Agreement shall be rendered or declared invalid by any court of competent jurisdiction, or by reason of it requiring any steps, actions or results, the remaining parts of this Agreement shall remain in full force and effect.
